

## **EXPERT COMMISSION ORDER**

We, Andre ANGIBAUD, Investigating Judge at the Court of First Instance of MATA'UTU,

In view of the information followed for the worrying disappearance of Messrs ABDUL RASHED SHUKREE, HASSAN DAWOUD and CALVIN ISAAC-FERRIS DANIAN, since 28 November 2020 11 Wallis;

Having regard to Articles 18 (paragraph 4), 80-4, 74, 74-1, 92 to 108, 151 et seq., D 12 of the Code of Criminal Procedure, 156 to 169-1 of the Code of Criminal Procedure;

Given the urgency;

Considering the impossibility of having recourse to a computer expert registered on the list of experts of the Court of Appeal of Noumea,

Appoint Mr. Laurent VEROLIN, operational section of fight against cyber threats, Meunier caseme, 98800 NOUMEA, designated as expert, who must first

to his operations take an oath in writing to carry out his mission in his honour and in his conscience, to to carry out the mission indicated below.

Let's say that the expert will submit a detailed report containing his reasoned opinion and a certificate that he has personally fulfilled the mission entrusted to him before 18 December 2020.

Let us recall that in application of article R 107 of the code of criminal procedure, when the amount of his expenses and fees exceeds 460€ (54.893 CFP francs), the expert must inform the court which has appointed him.

1° - Describe the seals and check their integrity;

2° - Search for the presence of photographs of the two missing persons and of characteristic signs of identification of the latter (tattoos, scars...) and in case of discovery of photographs allowing the identification of specific characteristics, extract them for a later exploitation;

3° - Do all research on the internet connections, the sites consulted and the people regularly in contact with the interested party on November 28, 2020, the two previous days and the following days, likely to allow the search for the two missing persons to be directed or to allow the circumstances and the context of their disappearance to be clarified;

Let's say that the expert will be allowed to reconstruct the seals after the expertise operations; In general, make any observations relevant to the investigations covered by this procedure and record your observations in a report.

The expert will submit, before 18/12/2020, a detailed report signed by him and mentioning the names and qualifications of persons who may have assisted him, under his control and responsibility, in the performance of operations deemed necessary by him for the execution of the mission entrusted to him, 111 accordance with Article 166 of the Code of Criminal Procedure.

In view of the urgency and the impossibility of postponing the expertise operations and the filing of the conclusions for a period of ten days, the expertise operations may begin without deadline;
