

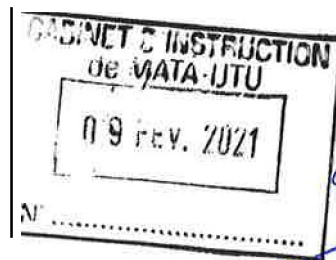

We analyze searches performed on Chrome between December 04, 2020 and December 07, 2020.

We do not find any trace of particular research. The connections concern the GMAIL box of SCHMIDT Michael, searches related to his activity "System Telephone", connections to YOUTUBE and in particular to videos dealing with strange phenomena, conspiracies, covid etc.

#### Special features :

We mention that SCHMIDT Michael frequently connects to a video that he himself has put online, dealing with sailing and his sailboat, video added to YOUTUBE on April 02, 2020.

The video is entitled BLUE WATER SAILING.

#### Conclusion:

The first research carried out by SCHMIDT Michael when he was able to connect to the internet, at As of 01/12/2020 morning, this concerns his mailbox as well as the data related to his GARMIN GPS.

Please note that GARMIN GPS allows you to receive and send emails and messages.

Apart from the fact that Michael SCHMIDT never stops watching videos about the end of the world, conspiracy, Covid, unexplained phenomena, we have not noted any research that would allow us to orient our investigation.

**COMMUNICATION BY ELECTRONIC MEANS DURING THE PROCEDURE**

The person heard does not agree to receive notices, summonses and documents relevant to the proceedings by electronic means.

After having taken an oath to tell the whole truth and nothing but the truth, the witness, heard separately and out of the presence of the accused, deposed as follows, through YARDLEY Andrea, English interpreter, who took the oath

I am not a parent, ally or servant of the parties. ----

**Question:** Can you retrace the events from the moment you enter the lagoon of Wallis on 28/11/2020? -----

**Answer:** Several days before arriving on WALLIS I contacted the Fijian authorities to advise them that he was coming to WALLIS because we were in an emergency situation, due to We had no drinking water and no food. -----

In FIDJI's first question was how many we were and I answered that we There were three of us. The next question was what our position was and I gave it to them. The Fijian authorities asked me to keep in touch with them every hour and from the next day onwards to contact them twice a day. All the information given to Fiji is recorded on the GARMIN GPS. -----

When I arrived outside the lagoon, I contacted the gendarmerie and we waited for the gendarmes to come to meet us. Three policemen came and talked with me. I saw the two passengers. The gendarmes asked us to follow them with the sailboat but I couldn't and I explained them that I had no engine. I tried to enter the pass but the wind was not favourable and I did not succeed despite several attempts during more than one hour. --- ----

This explains the tracks left on the GPS. -----

The gendarmes asked me to anchor myself outside and that I should try the next day. I have asked how I could get in and the gendarmes said that a boat would come and tow me in.

I dropped anchor. Three hours later a boat came to meet us, and the pilot told me that he had offered to tow me for the sum of \$1500 but I refused and said I would wait until the next day when the wind was right. -----

I stayed outside the lagoon until the next day. I prepared the sailboat to enter the next day and I have also prepared the appendix. -----

The next day the winds were still unfavourable so we stayed outside the lagoon. The two passengers cleaned the boat, well the hull. We waited for the water to rise. I saw one of the gendarmes coming to the pass on the diving club boat. I didn't know it was him. but he told me about it later. -----

The wind changed, the tide was rising and I weighed anchor to enter the channel. -----

Before I weighed anchor, Abdul RASHED was worried that we would not wait for the gendarmerie. He was very nervous and worried. He didn't understand why we were going in without waiting for the police boat. I think he was trying to gain time, I don't know why, but I imagine he was trying to gain time. that he was trying to come up with a plan. I told him that I had prepared some points on the GPS in the cabin and that once we got to the last point, I would drop anchor and call the police at that time. -----

I had to stay at the top of the rudder while the GPS was at the bottom. I asked Abdul Rashed to stay below and tell me when we would arrive at the various points I had marked. -----

Abdul said at some point "be careful, the current is very strong in the pass". This information is present on the GPS data. -----

I asked Abdul because he was older, calmer than Calvin Isaac, who is younger and more airheaded. -----

**Question:** Was Calvin Isaac also nervous about entering the lagoon? -----

**Answer:** To me Calvin Isaac was like a soldier being dropped off at war. He was not listening. I asked him to stand by. He started tying the ropes the wrong way. I asked him why he started doing things the wrong way. In hindsight I think they were not thinking about what was going on on the boat, they were thinking about something else. I have it yelling at me as we walked into the lagoon. -----

I asked him if he saw people in the water. He didn't tell me that there were people swimming near the water. Calvin was on the pant and he saw these people. Calvin replied "What?". He wasn't focused. Calvin was on the starboard side, the boat was leaning to starboard, and he was advancing rapidly. -----

**Question:** Can you continue your story ? -----

**Answer:** I saw the people who were on the islet of the pass, on the starboard side, and those who were swimming close by, who seemed surprised to see us enter the lagoon -----

**They were all looking** towards us -----

Abdul went back up to the pant once we had just passed the bathers. I told him to come back down as we were about to arrive at the first GPS point I had noted on the cabin GPS. Abdul went back down. -----

I kept asking him if we had hit the next GPS point and he didn't answer. I don't know if he went back up to take a look. I felt like they were getting stupid. I had the impression that they were becoming stupid in their behaviour. I thought they were excited by the situation. Normally Calvin would stay on the pant and Abdul would stay downstairs. -----

**Aumoment** gives Calvin went down. The wind dropped and the boat slowed down. I started to drift towards the reef. I was worried and called them to come back to the pant. I went down to look at the GPS to see how far I was from the next GPS bridge, and how far from the reef. After looking at the GPS I went back up and sent the boys to their paste. They were back on the bridge when I came down. -----

I was the one who told them to go back up while I looked at the GPS. When I went back up I asked them several times to return to their posts. Abdul went back down to look at the GPS. Calvin stayed on the bridge and did nothing. I asked Abdul several times if we were touching the GPS point but he wasn't answering.

I knew more or less where this GPS point was

Calvin went downstairs as well. At that moment I heard the radio playing in the background. Abdul said to me "why is the radio doing that". I said "I don't know, have you touched it"? He said no. In my head I thought that he must have touched it because the radio does not make that noise all the time alone.

I told him not to touch anything on the GPS but he did before we entered the lagoon.

Abdul asked me to go down to check the radio. I was at the helm manoeuvring because the wind had picked up. I want to point out that when you have your own boat, you are under pressure when you are sailing in unfamiliar waters. Abdul turned up the volume on the radio. I told him I wouldn't come down.

Abdul insisted again that I come down but I told him I would not. I told him to turn off the radio. Abdul asked if I didn't need to call the police and I told him again to just turn it off. I could not see Abdul from the cockpit.

I asked him again if I was at the point noted on the GPS and he did not answer me again

Now I understand why he wanted me to come down to see the radio. For me they wanted me to come down so that Calvin could take the **GARMIN** GPS that was hanging on the helm.

I must say that once we passed the bathers in front of the island, I sent a text message with the Garmin to the gendarmerie to say that we had just returned. That's when they started to behave strangely.

Abdul turned down the radio. I then saw that the radios microphones had been turned off and I realized that the background noise of the radio was coming from there.

After I refused to go down to see the radio, Abdul came up and jumped into the lagoon on the port side. He is dressed in a t-shirt, shorts and he had a small bag the size of an eyeglass case, grey in colour in his hand. That's all he had.

I was surprised when he came to the surface because he still had that case in his hand. I shouted at him, "What the hell are you doing? He didn't answer me. I was amazed, but then I got angry very quickly.

From the corner of my eye I saw Calvin Isaac coming out of the cabin, wearing shorts and a t-shirt. He walked past me and jumped to the port side. He said as he passed me, "Sorry about that. He had nothing in his hands. I later found a pouch of the same size and colour as the one Abdul had taken. It was under the table on a tarpaulin of the same color as the bag. I think Calvin must have been looking for this bag and that is why he jumped into the water about 10 or 15 seconds after Abdul. I'm not sure about that. It's like time stood still for me.

I told myself that I could not help them because they would not want it. I thought I would call the police who could pick them up with their motor boat. I went down to use the radio but I couldn't because the cables were cut. I contacted the gendarmerie via the Garmin but got no answer. I sent a message to an email address of the gendarmerie. I did not get an answer. I then thought of lowering the sails and throwing the anchor. I first went down to look at the depths on the GPS to see the depths. As I didn't have an engine I had to find a place to drop the anchor. I also knew that the cargo ship was due to leave and I didn't want to get in its way.

I lowered the sails and dropped the anchor. I contacted Fiji but got no answer. I told them about the situation but I didn't get an answer

I saw a boat of fishermen and waved to them. I explained the situation to them and they left to look for Abdul and Calvin.

I sent a second message to Fiji asking why no one was responding to me. Fiji replied at that time and told me that the police had been notified and that the gendarmes were about to arrive.

The fishermen's boat came back to ask for clarification and they left. The gendarmerie arrived an hour or two after I got Fiji the second time.

The second message to the gendarmerie I sent not long after the one where I said we had just entered the lagoon. -----

I think that both of them jumped after I sent a message saying that we were going to drop anchor to wait for the police. -----

When the gendarmes arrived at the canopy, they asked me for the information from the Garmin and I gave them the camera. They took pictures of the screen. -----

**On the reasons for Abdul and Calvin's flight:**

**Question:** Why do you think the two passengers jumped into the water ----- ?

**Answer:** As far as I was concerned they didn't want to do the covid test. They told me this several times. They told me this when we were near PAGO PAGO, when I was trying to get back to the port.

**Question:** Why don't you dock at PAGO PAGO? -----

**Answer:** There was no wind. I was drifting and the entrance was very narrow. I made several mistakes. The first one is that I translated the radio codes by telling them that the Samoa police was coming for the covid tests. I didn't want to take the risk of crashing on the rocks or the beach. -----

My second mistake was telling them that I had contacted the gendarmerie when I entered the lagoon in WALLIS. -----

**Question:** When you turn around in PAGO PAGO, what is your ----- situatio  
n?

**Answer:** We had the same damage, the engine is out of order. We only had a little drinking water. As far as food is concerned, there were about 30 kilos of rice left. -----

**Question:** What is the reason why you don't stop at PAGO PAGO? -----

**Answer:** There are several. There was no wind, the boat was drifting towards the beach and the fact that both refused the PCR test. The authorities in PAGO PAGO wanted us to moor at a place that I didn't know. -----

I was also afraid of the weather changes, with violent winds for a quarter of an hour and I was afraid of losing control of the boat. This morning we had three such squalls, with zero visibility.

**Question:** Wasn't the real reason the two passengers categorically refused the PCR tests? -----

**Answer:** No, it's the combination of all the elements. I was going to wait on PAGO PAGO at first. I contacted a friend in HAWAI who told me that maybe the two passengers were wanted by the police. I sent him the identity information of the two passengers and he did some research and replied that they were not wanted. This friend, AIR JORDAN, advised me to go to WALLIS. He thought that WALLIS was open like French Polynesia. -----

Originally we were supposed to go to RAROTONGA but after 400 miles we learned that we could not dock there. The other boat with MAC KINLEY, went to BORA BORA. I proposed to go to FIDJI but we took monstrous storms -----

The waves were so big that I broke my nose on the rudder. At 500 miles from BORA BORA I decided to turn back and AIR JORDAN advised me to go to SAMOAS Americans. -----

**Question:** Why are your passengers against the covid test? -----

**Answer:** They think that the cotton swabs used contain nano technology. They believe that it is the end of the world. they spent their day reading the bible and only ate once a day. sun Layer. -----

He didn't want to use my plates and pans anymore because I had cooked pore. He didn't do that until Abdul came ON board. A witness living in UTUFUA sees you clearly and follows you with his eyes as he is practicing He is intrigued because he thinks that the sailboat he is looking at is CHARDIGNY's. The angle of view from the terrace of this witness leaves no doubt as to a possible mistake due to the angle of view. What do you say?

**Answer:** I was able to make a loop to get to the anchorage but I did not approach the ot FAIOA I approached the reef of FAIOA in the evening when I pulled anchor and the gendarmes were the.

**Question:** Would you have dropped off the two passengers north of FAIOA?

**Answer:** No.

**Question:** You indicated in your first statements that the two passengers jumped into the water just after you sent the message to say you had entered the lagoon at 12:09. Can you confirm this?

**Answer:** Yes I confirm it. I typed this message with the garmin

**Question:** Do you confirm that you sent the alert message that the two passengers jumped into the water and that you are requesting that the authorities come to meet you, this has been done. 12H15 of your GPS ?

**Question:** How do you explain the fact that it takes 06 minutes to give the alert?

**Reply:** I went as fast as I could to send this message

**Question:** You say that your boat is going fast but the speed given at the GPS point of At 12:15 pm, the speed is 3.7 Knots or about 6.85 KM/H. This does not represent an excessive speed. Couldn't you have lowered your sail to stop as close as possible to the place where the people jumped into the water?

**Answer:** If my engine was working I would have lowered the sail but as I had no engine I could not do anything. I could have made a turn with the engine or I could have gone to throw anchor quickly.

**Question:** Did you follow the two swimmers with your eyes?

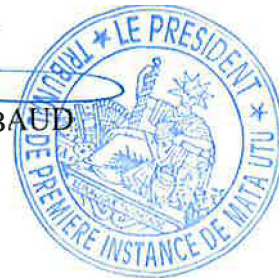
