SURVEY

01 On 07/12/2020, a search was conducted on the sailing boat ZULU TIME, and technical findings were made by CHARDIGNY Louis Henry, a sailing expert, and KALINOWSKI Alexandre, a criminal identification technician.

These operations show that:

- All the clothes and objects belonging to CALVIN ISAAC and ABDUL RASHED have been analysis by the criminal identification technician and then seized by the judicial police officer.

We would like to point out that we could only rely on the designation made by Michael SCHMIDT, the captain of the yacht, to carry out the sharing of the affairs.

The reports of the qualified persons were forwarded directly to the investigating judge Andre **ANGIBAUD**.

Let us mention finally that the search on the sailing boat ZULU TIME was stopped on 07/12/2020 at 22H30, due to the bad weather conditions. Moreover, the yacht could not be placed under seal as an emergency tow had to be organised to move her away from the MATA UTU quay.

02 On 08/12/2020, we proceeded to the seizure of various clothes and objects, which SCHMIDT Michael had offered to SEMOA Sosefo, or thrown in the trash of the hotel of the latter.
