In general, to make all observations useful for the manifestation of the truth and to record your observations in a report.

#### SEARCH

From 07 December 2020 to 10 December 2020, acting within the framework of the procedure of reference diligent on the grounds of SUSPECTED DISAPPEARANCES, we intervene in order to carry out detection of latent traces of blood on the following elements relating to the searches carried out in connection with the vessel ZULU TIME :

Outside and inside deck of the cabin of the vessel ZULU TIME at anchor in Mata-utu bay and led  $t_{
m O}$ the mooring of the bay's quay. (1) Two kraft bags of the Captain's "dirty" clothes. (2)

Various cases and veternents designated as belonging  $t_0$  one of the missing who will be named A. (3) The tender of the vessel "ZULU TIME". (4)

Various items of clothing and belongings designated as belonging to one of the missing persons who will be named B. (5)

Various items belonging to the missing, discarded or given away by the Captain of the ship after the disappearances. (6)

Various items found on the "ZULU TIME" during the search on 09 December 2020. (7) A payment card given by the Captain of the vessel. (8)

Operations will take place in several stages, as follows: On 07/12/2020, during the search of the vessel " ZULU TIME >>. Throughout the day of 08/12/2020 at the Brigade de Gendarmerie of WALLIS. The morning of 09/12/2020 after the continuation of the search of the "ZULU TIME" in the WALLIS Gendarmerie Brigade.

The morning of 10/12/2020 following the delivery of the payment card of one of the victims by the Captain of the ship.

For the realization of our operations, we use a container of the quay of the bay of Mata-Utu, as well as the room of one of the residences of the Brigade of Gendarmerie of WALLIS.

We were assisted by Chief Warrant Officer TCHONG Manuella, Criminal Identification Technician of the WALLIS Gendarmerie Brigade.

#### **TECHNICAL PROTOCOL USED**

#### 1°/ Concerning the BLUESTAR® product:

The chemical used is a luminol-based formulation called BLUESTAR®.

This is a **presumptive test** used for the detection of latent blood traces.

This chemical product, non-aggressive towards DNA, is a catalytic test which oxidizes on contact with hemoglobin or its derivatives.


A positive reaction is characterized by the immediate production of a blue luminescence, visible only in the dark. This positive reaction is fleeting. It cannot exceed two minutes.

BLUESTAR® may cause positive reactions on non-bloody media. These reactions are commonly referred to as "false positives". A visual discrimination allows to eliminate some of these "false positives" (ex: bleach - rust...)

The existence of "false positives" makes it necessary to take a sample of the luminescent traces in order to confirm the blood origin of the observed reaction and to determine, if possible, the genetic profile of the traces.

It should be noted that the sensitivity of BLUESTAR® is such that it will not always be possible to extract a gene profile from a luminescent reaction.

#### 2°/ BLUESTAR® product use procedure:

When the product is ready to use, we check its effectiveness on a test cloth before starting detection operations.

BLUESTAR® is applied by manual spraying. During detection operations :

We wear single-use personal protective equipment (*gloves*, gloves, etc.).

*mask - suit - overshoes.*) We make photographic cliches of the detected luminescent traces.

During sampling operations :

We use sterile, single-use sampling instruments (swabs, gas), nippers and scalpels).

The samples are then packed in kraft paper.

FINDINGS

The operations are carried out in the continuity of the finds before their conditioning and seizure.

#### Item Description:

- A) (1): Ship cc ZULU TIME ":-
  - 1. Description of the element

It is a sailing ship with a single mast and no markings on its sides. The registration of the boat has not been communicated to us. The boat was detached from its mooring and towed to the bay quay by the WALLIS Gendarmerie.

We are proceeding with the findings in and on the vessel. It should be noted that the conditions will not allow us to make accurate measurements of the vessel

On the deck of the ship, we discover various ropes and foam seats. At the stern, next to the helm, we see a small outboard engine with a dismantled propeller.

Inside the cabin there is a central living area with a kitchen area with a gas stove and a sink. There are also two benches with a small central table and a "card table" on the right side of the cabin.

Further forward, we find a door to the bathroom which includes a shower, a toilet and a sink and a toilet seat.

In the foremost area of the ship, we find a cabin with a single triangular bunk that follows the shape of the ship's hull. On the bunk, we notice a pile of dirty clothes, which are designated as belonging to the Captain.



life jackets are stored under this board. We note the presence of a manual pump placed on the ground at the back. Let us mention that an inscription " ZUKA " is readable on the right front ! of the annex.

#### Search for traces

· · ·

- The aim is to search for visible or latent blood traces on the above-mentioned objects.

- First, we perform a visual search with a CRIMELIGHT 2® lamp in white light (wavelength 400-700 nm) without filter, then in blue light (wavelength 420-470 nm) with yellow and orange filters.

During all the operations ii is noted on :

(1):

1. Inside the cabin :

Several black scratches on a right seat cushion, rated 1. A dry reddish mark on a right seat cushion, rated 2. A reddish dry mark on a right seat cushion, marked 3. Two dark dry marks on a right seat cushion, marked 4. A reddish trace on a small table near the right bench, marked 5. Two luminescent marks on a cushion of the left seat, marked 6. A reddish mark on a cushion of the left seat, marked 7.

Let us mention that every reddish or dark trace 1S tested for human blood. All these tests are negative.

2. On the ship's deck :

No reddish or brownish traces were found.

(2):

A clear trace on the lower right leg of a pair of black shorts, designated C4. Several blue-light luminescent microstains OII the surface of a white t-shirt, designated E2.

Two small luminescent traces under blue light OI the surface of a long-sleeved shirt, is called E3.

A whitish trace on the bottom of a black T-shirt calls F1.

Whitish marks on the collar of a black T-shirt, name F4. White traces on the surface of a black short, name G3.

View of luminescent traces under blue light On the surface of a blue t-shirt named L3.

- After each blue light search, we carry out a detection of latent blood traces in accordance with the MI-021 method of investigation of the Gendarmerie Criminalistics Manual (MCG) on the interior and exterior of the ship, its tender and all clothing and belongings related to the case.

- Before any research is carried out, a test is carried out to check the validity of the product used (Bluestar®). The test is positive.

On December 07, 2020, a chemical detection of latent blood traces is performed.

This detection was positive on a very small area of the bridge near the storage area of the

lifeboat. Considering the duration of luminescence, it is very likely to be a false positive. A swab is still taken at this level. The other elements show no reaction.

In addition to the trace detection, we mention that all sampling and packaging must be carried out 1n parallel with the trace detection. to identify the missing, including a passport in the name of DANIAN Calvin Isaac-Ferris, elementals on a sheet, a wedge and a cap, two fathoms, two mini plastic cards, two notebooks

of writing with leather cover. It is the same for a blue card given by the Captain of the ship in the name of DANIAN Calvin Isaac-Ferris.

Whereas the continuation of the search for the missing persons who are the subject of the present proceedings requires the carrying out of technical operations of findings and analyses concerning

That, in view of the urgency of the matter, due to the time that has already elapsed since the disappearances, and the risk of loss of clues that could guide the search, the absence of an expert on the list of experts of the Court of Appeal of Noumea present on the territory or likely to be found there in the near future, there are grounds for committing:






